How to successfully participate in the online meeting

Please REGISTER for the meeting and you will receive your entry code and link.

BEFORE attending the online meeting, please make sure you prepare properly.

- 1. Take some time in advance to set up your technical system
 - a. Switch on the microphone
 - b. Check your internet connection
 - c. Make sure you have all login information at hand
- 2. Enter the meeting and edit your online identification
 - a. Join the meeting at least **five minutes before start**
 - b. Make sure you are labelled correctly to easily identify each one in discussion. These rules should apply: name, surname, 3 capital letter for country, nr. of project partner from your country, abbreviation of your rule in the project (Project partner = PP; Associated Strategic partner = ASP, Expert = E), institution: i.e. *Gregor Steklačič SLO PP4, PP, Ministry of Infrastructure*.
 - c. Because in an online meeting there is no possibility to sign a participant list, the organizer will use the Chat to send link to questionnaire to all participants, where you will insert your name, organisation, phone number and email as prove of your participation (towards the FLC)
- 3. Adjust the frame
 - a. Make sure your webcam is at eye-level
 - b. Minimise background distractions (remember that everything behind you such as furniture, books, cats etc. can be seen by all participants)
- 4. Maximise the light in your room: If there's not enough light in the room, the camera has to compensate and your picture becomes blurry or dark
 - a. Open the shades, switch on all lights and point them at YOU.
 - b. Make sure the sun or the light is NOT hitting your camera frame directly.

DURING the meeting, please stick to the rules and codes.

An online workshop is a bit more challenging in terms of participant interaction.

- 1. For this reason, the moderator gains a more important role steering the conversation.
 - a. Pay respect to the speakers, listen attentively and do not distract yourself or others with background activity (switch off your mobile phone, online notifications, email account etc.)
 - b. Raise your hand if you have a comment or question.
 - c. When given turn, speak clearly and slowly.
 - d. Try to avoid speaking simultaneously with other participants. Let them finish their sentences and wait until appointed speech by the moderator.
- 2. Use the Chat for questions, comments, suggestions as a tool for more interactive discussion.
